Youth Rules for Horticulture Exhibit in Howard County Garden Club Flower Show

- 1. Plants on the Maryland Department of Natural Resources list of Rare Threatened or Endangered Plants at http://dnr.maryland.gov/wildlife/Documents/rte_Plant_List.pdf may not be exhibited in the Horticulture Division. Invasive Plants as determined by the Maryland Invasive Species Council may not be use. See http://www.mdinvasivesp.org/list_terrestrial_plants.html.
- 2. Specimens will be displayed in a clean, colorless, transparent glass container without labels, handles, or conspicuous markings, appropriately sized for the specimen (provided by exhibitor).
- 3. Containers will be filled with water; however, cut specimen should not have foliage below the waterline, except for Gladiolus.
- 4. Wedging consisting of bubble wrap or plastic wrap may be used to keep specimen upright (furnished by the exhibitor).
- 5. Youth from the age of 8 to 18 who participate in activities and programs at the Enchanted Garden and/or youth relatives of Howard County Garden Club members are eligible to exhibit.
- 6. Only one entry will be accepted per exhibitor. Entries will be limited to the first 25 entries.
- 7. Specimens may come from Enchanted Garden or exhibitor's family garden.
- 8. Classes will not be divided by species or age group.
- 9. An index card will be completed for entries with the following information: Exhibitor's first name, Initial of last name, age, common name of specimen and binomial name, if possible.
- 10. Entries will not be judged. However, the Chair of the Youth Committee will provide comments on the entry.
- 11. Participation Ribbons will be awarded to each exhibitor.
- 12. Entries will be received between 8:00 and 9:00 am on September 13, 2024 and must be removed between 3:30 and 4:00 pm.
- 13. Entries not picked up will be discarded.
